## 2009/10 MEMBERSHIP POLICIES AND PROCEDURES

### **Reservations**

Members will have the ability to reserve tee times at Golf Without Limits 3 days in advance.

### **Cancellations**

Lesson and Tee Time cancellations must be submitted at least 24 hours in advance regardless of weather conditions. Any tee times that are not properly cancelled will be charged a \$25 cancellation fee for each no show. Members should keep a record of each cancellation number given by GWL staff member or online booking system.

### **Food & Beverage**

Members are encouraged to support Food and Beverage services at Golf Without Limits however no minimum spending levels will be enforced.

### **Anytime Access**

Anytime Access is subject to availability. Members require a \$10 Green Fee for Studio rental between Saturday 9am and Sunday at 5pm. Any time beyond the allocated member hour will be charged at the Member Green Fee rate.

### **Membership Term**

Memberships are subject to applicable GST. The membership term will be billed on an ongoing monthly basis starting from the date of application acceptance. All memberships are based on a minimum 12-month term. All preauthorized monthly memberships will be subject to a \$99 registration fee. Cancellation of the term must be done so in writing at least 60 days prior to taking effect. GWL does not prorate monthly charges upon cancellation. A \$199 cancellation fee applies for early termination.

### **Member Green Fees**

All members will receive a 25% discount from the standard hourly rate.

### **Speed of Play**

Please make sure you book enough time to play. Golf Without Limits books one hour per golfer for 18 holes unless otherwise specified. We are not responsible if you do not finish your round.

### **Club Events and Leagues**

All members are eligible to participate in club events. Club Events will be booked on a first come first serve basis and may be subject to a participation fee depending on the venue. A \$10.00 Weekly League Fee will apply for all participants and includes a \$5 contribution to skins.

### **Member Benefit Programs**

Members will receive monthly discounts on various products and services including local golf, golf products, restaurants, entertainment, personal services, etc.

### **General**
